#### REPORT OF BROCK REGIONAL COUNCIL

Brock Region encompasses the half of the Niagara Peninsula that includes Dunnville, Wainfleet, Port Colborne, Fort Erie, Niagara Falls, Fonthill and Welland. A total of fifteen parishes are represented at meetings the first Wednesday of the month, each at a different parish even though distances can be daunting.

The format of most meetings is a presentation by a guest speaker on either a topical subject or an activity of the Church which needs support or wider understanding. These are followed by a brief social period with refreshments, after which we attend to the business portion.

An important element of the business meeting is the report from Synod Council which updates parishes on the various matters of concern from the Diocese and any proposed changes to Canon law or policies and the budget intentions. The last portion of the evening is devoted to each of the parishes sharing their upcoming events and activities, including the successes of the previous month. It is also an opportunity for parishes to exchange new ideas and discover new ways in which to grow.

This year, we have had discussions on the "Response to the Windsor Report". The Bishop's visit allowed us an opportunity to express our concerns and ideas and to enter into a meaningful dialogue. As a follow up, the council struck a committee to review the role of the council in providing support to the regional parishes regarding same sex marriages and to make recommendations to the council. The Bishop also spoke at length about the Pope's passing and his memories of the man. As is his character, the Bishop also added some levity to provide distraction from the weighty topics.

We were able to celebrate the arrival of summer and our hiatus as well as the contributions of the members of our council, with a pot luck supper at the lakeside home of Bill and Helen Coons.

We look forward to hearing from the parishes in other regions and we will continue to promote their events and achievements throughout the Brock Region.

#### REPORT OF UNDERMOUNT REGIONAL COUNCIL

As to Cannon 1.10 Regional Council is charged to:

- > Develop and administer an annual outreach budget
- > Support and encourage ministry in response to local community needs
- Encourage and respond to requests from parishes, groups and individuals regarding support for local outreach activities
- ➤ Arrange appropriate inter-parish and ecumenical cooperation
- ➤ Plan and arrange leadership training to support congregational development and community projects
- Enable parishes to share information with each other regarding their programs with at least one annual gathering of parish leaders
- ➤ Refer individual, parish and regional concerns and suggestions to the appropriate diocesan body and
- Research debate and prepare resolutions to be forwarded to Synod.

The Diocese of Niagara has 6 different regions with the Undermount Region nestled in the middle, with the smallest land mass. We are the Twelve Tribes of Undermount Region stretching from St. John's, Hamilton, as far east to St. John's Winona, north to the lake and south to the escarpment. We include a wide variety of people and cultures, from the founding fathers and fur hats of Hamilton, to the homeless, from high density dwellings to almost rural country homes, from Anglo-Catholic liturgies to traditional liturgies to very modern liturgies. We are very diverse!

In December of 2004, the need for Christmas gifts for seniors at St. Matthew's House was recognized and Undermount Region Council created 40 gift boxes for both men and women containing such items as toothpaste and brush, deodorant, hard candy, socks, hand lotion, and jam. It is easy to remember the children and families at Christmastime and often the less fortunate seniors are forgotten. The boxes were very well received.

2005 has seen a turnover in some of the leadership roles and membership in our council, as some of the terms come to an end with vestry and new members are elected to represent their parishes. Carol Burnell is the newly elected chair, as we wished the retiring chair, Susan Little, a fond goodbye. Ruth Anne Martin accepted the role of secretary, replacing Tim Standish.

Our Council had the privilege of naming 2 clergy and 2 lay representatives for the nominations for Provincial Synod in October 2006. We nominated Steve Hopkins, and Sandy Copland as the two clergy, and Susan Little and Paul Mansfield as the two lay representatives.

The Council is taking a very active part in the Undermount Review process. The Bishop has asked the Archdeacon of Undermount to oversee the development of a mission and ministry plan for the region that addresses several concerns. As part of the Mandate, Regional Council is asked to support to assist him in this task. After a series of spring meetings the next step is a visioning day "Discerning God's Future for Undermount", held at Christ Church Cathedral using Open Space technology on September 10, 2005. The purpose of this day is to pray, to dream, to share, to work, and to build a future together.

We made the difficult decision to cancel Praise All ways this year. It takes a lot of organization and work as we decided to focus our energies on the Undermount Review Process.

As liaison between the Tribes, the representatives share with one another the everyday joys and struggles of parish life offering the support of the larger community. The blessing of being on Regional Council is learning that much more can be accomplished when we work together as team rather than as individual tribes.

#### REPORT OF THE DIOCESAN ARCHIVIST

There are still a few parishes which have not taken advantage of our Diocesan policy under Canon 2.6 to store valuable parish registers, vestry and other minute books plans and blueprints at McMaster University. Copies of registers are made and returned to the parish for research. There is, of course, no charge for this service. Also there are a number of parishes which have not sent any registers for a few years. Please check and get these in to me at Cathedral Place and begin new registers.

The closing of some churches in Hamilton, St. Catharines and Niagara Falls has brought many registers to me. Some of the new registers contain additional information such as the place of internment of cremated remains. As you are aware there are no rules or laws regulating <u>Ashes</u> but I feel some note should be recorded at the time of burial so future researchers can know what has happened to them.

If you have sent registers in to me lately the copying sometimes takes a while as McMaster will save them before taking them to Toronto. I can always access any register sent to me.

As they don't teach penmanship in schools any more - please - where a name or signature is required - please print the name clearly as well as signing. This will help greatly in deciphering names especially for any legal purposes.

I sometimes get a request for information which can better be dealt with in the parish, especially if there is a parish archivist who has the time and knowledge of the parish history. I am grateful to parish rectors for assisting me in this way.

I do accumulate, besides all the above mentioned registers etc., some material things - vestments, albs, cassocks, cemetery capes, copes, baptismal ewers, collection plates, and other bits of "holy hardware".

I do have a file on each parish which might be helpful to any parish contemplating writing a parish history. If such a history is written please send me a (free) copy for my records. I also have some blueprints and plans which can be borrowed for your Decennial inspection by the Bishop's Advisory Committee on Church Buildings. Do parish clergy know what is kept at McMaster University for their parish? If not, please contact me at Cathedral Place 905-527-1316 extension 450.

#### REPORT OF THE DIOCESAN CEMETERY ADVISORY COMMITTEE

The Cemetery Advisory Committee was established approximately two years ago as the Province began a process of introducing revised legislation and significant changes relating to the bereavement industry under proposed Bill 209. This new Bill will significantly influence both the current Cemeteries and Funeral Services Acts. The Cemetery Advisory Committee functions primarily to assist parishes offering the disposition and care of human remains under the authority of the present Cemetery Act (1992) and to disseminate and interpret information and advise parishes as new legislation is introduced and enacted.

The newly Revised Act, being introduced in five separate clusters and intended to receive final reading in the Autumn of 2005, has progressed at a far slower rate than anticipated. At the present time, only three of the five clusters have received approval. It appears evident that at least another year will pass before the Bill receives final assent. The newly revised legislation is intended to influence and govern all segments of the funeral industry currently operating both within and outside the present Funeral/Cemetery Acts. With the introduction of Bill 209, it will establish clear rules under which combinations (joint ownership of funeral establishments and cemeteries or funeral establishments and crematoria) can be permitted. It establishes regulations for industry related services which are currently outside the Cemeteries Act (1992) and Funeral Services Act. These include monument dealers, transfer services, casket dealers, retail funeral supply outlets, and cemetery sales persons. All service and funeral related providers, their employees, and those in volunteer positions will require licensing.

While it may appear intimidating and threatening to some, Bill 209 strengthens consumer protection within the entire bereavement sector. It provides protection for consumers at a time when they are most vulnerable in their decision making process; provides a 30-day cooling off period, and entrusts preneed consumer funds to ensure they receive a full refund should they change their mind and wish to cancel their purchase for any reason. The Bill provides for enforcement mechanisms ensuring that all industry participants must adhere to a provincially acceptable code of ethics. It is a bill that clearly has the best interests of the consumer as its primary intent.

Over the past year, the Cemetery Advisory Committee has assisted several parishes as they endeavor to meet requirements under the present Cemeteries Act, and to prepare for the new legislation. In an effort to obtain current information and helpful advice relating to the newly proposed legislation, the Diocese became a member of the OACFP (Ontario Association of Cemeteries and Funeral Professionals) earlier this year. This association remains in close dialogue with the Provincial Government, providing comment and suggestions to its members as segments of the new legislation are introduced.

As part of the Diocesan Resource Centre, the Cemetery Advisory Committee extends an invitation to all parishes seeking help or advice relating to cemetery issues and/or interment. ## CHRIST'S CHURCH CATHEDRAL SYNOD MEMORIAL

The congregation of Christ's Church Cathedral, through its Cathedral Council, wishes to share with the members of Synod their considerable anxiety, pain, and anguish over the current situation in the Church regarding the Blessing of Same Sex Unions.

While we at the Cathedral accept the sad reality that the Anglican Communion is deeply divided over this issue and, more positively, that our Bishops and Synodical structures are deeply committed to holding the Communion together, we cannot ignore the fact that many are in deep pain over the hurt caused to our gay and lesbian brothers and sisters, and therefore to all of us.

While the April 2005 statement of the Canadian House of Bishops and the events at the Anglican Consultative Council meeting in June 2005 have doubtlessly lowered the temperature on potentially divisive issues and actions, they have left many of our own congregants seriously concerned. We struggle with the perception that we simply can ask a whole segment of God's children to continue to wait unreasonably and unacceptably long amounts of time for their full inclusion in our Anglican family.

We sincerely regret this and call on our Synod to re-affirm, in the midst of a time of waiting, our Diocese's strong commitment to the inclusion of all, and to the integrity and sanctity of adult committed same sex relationships.
