Welcome to Diocesan Synod 2009

Living The Vision: A Diocesan Celebration!

Welcome to the 135th Synod of the Diocese of Niagara, this has the potential to be one of the most interesting and significant synod's you have ever attended. Thank you for offering your gifts in the leadership of our diocese.

WHAT TO EXPECT:

This is a two day Synod beginning Friday morning and ending Saturday afternoon.

Core Business of Synod on Friday

The core business of this day will be to hear the Bishop's Charge, elect Synod Council, elect members to General Synod, approve financial statements, discuss the budget, receive reports, and vote on one Canon change. Registration begins at 8 a.m. with business beginning at 9 a.m.

Electing Members of General Synod

General Synod meets every three years. The next meeting will be in Halifax, Nova Scotia, from June 3rd to 11th, 2010. We will be electing 5 clergy and 5 lay delegate members of General Synod (the Bishop and Chancellor are members ex-officio), in addition the Bishop has appointed Dean Sutton-Greenhalgh as our youth delegate. Clergy elect the clergy and laity elect the lay delegates. Nominations were solicited through Archdeacons and Regional Councils, in the Niagara Anglican and on the diocesan website. The Coordinating Team of Synod Council acted as the nominating committee, ensuring that enough nominations were received in both orders, that there was an equal number of male and female nominations, and that the biographies of all nominees were made available. It is possible for nominations to occur from the floor of Synod. Nominees would be offered the opportunity to address Synod delegates and would be invited to a microphone to give a 60 word biography orally. Ballots will be given to all delegates at registration and no replacement ballots will be available.

Synod continues with a dramatic day of celebration for all members of the diocese. This means that Synod is still in session but all members of our parishes, who wish to attend, will be given the opportunity to join with us in a day of education and inspiration. Here is what to expect:

REPORT OF THE BISHOP'S ADVISORY COMMITTEE ON CHURCH BUILDINGS

The Bishop's Advisory Committee on Church Buildings exists to bring together the collected experience of those who work professionally in the construction industries, to the service of parishes with building maintenance problems or those planning capital investments.

Spending money is too easy. Spending it wisely though, in order to get the most from it, requires particular diligence and care, not just in the planning and design but in the management processes and in the financing of every project. Members of the committee provide their knowledge free-of-charge, in a friendly manner and are focused on the best interests of parishes. They are not called to criticize or second guess; they are called, however, to real economy and true welfare.

Of growing concern in our deliberations are the sometimes conflicting issues, on the one hand, of Heritage Designations and, on the other, of environmental imperatives; including the important diocesan initiative for "Greening Niagara."

Over the past year committee members have provided advice to the parishes of St. Aidan's, Oakville; St. Luke's, Palermo; St. Mark's, Orangeville; Church of Our Saviour, the Redeemer, Stoney Creek; St. Paul's, Shelburne and All Saints', Hamilton.

There is a description of the resources offered by the committee, and of the diocesan requirements around new construction projects, that can be viewed on the diocesan website under "Resources-Church Buildings Committee" or you can call Karen Nowicki at 905-527-1316 x 380 for immediate service, or you can contact the Committee Chair, the Reverend Ian Chadwick at 905-988-7873 or stalbans@vaxxine.com if the matter is sufficiently desperate to require prayer.

If, in your parish, you are anxious about some structural weakness in the church fabric, or some maintenance issue with the potential to cause trouble, call Karen, or Ian, and get yourself some expert advice: it could save you some sleepless nights and save the parish a bundle.

A particular thank you to the dedicated volunteers who are the committee members. Those long drives to evening meetings at the other end of the diocese may be a satisfaction, but we recognize and appreciate that they come at the personal price of time and effort. But what we maintain and build together is not just good stewardship, but of Glory to God.

REPORT OF THE BISHOP'S DECENNIAL INSPECTION COMMITTEE

As a result of the economic turmoil and uncertainty of the past 18 months, 2009 has been a difficult year for the inspection program. In many cases Parishes have been reluctant to make the necessary commitment to an Inspection, mainly due to financial constraints and changes to staff and key volunteers. Somewhat surprisingly Inspectors have been unusually busy and trying to work with reduced personnel; in addition one inspector who has worked for the Diocese for more than ten years has had to resigned due to ill health. At present we have three pre-qualified Inspectors on the roster; one has indicated his intention to resign in the near future, and we are actively searching for three new Inspectors to join the team before the 2010 program begins.

16 Inspections of Diocesan property were scheduled for 2009. Of these, only three have been completed as of the date of writing. Through the good offices of the Archdeacons it is hoped that the majority of the remainder will be completed before winter or at least will have an Inspector nominated and a firm schedule for completion. The schedule of Inspections for 2009 was full in order to reach the goal of having every property in the Diocese inspected within the initial ten years. After that in 2010 the second cycle of Inspections will start. In the meantime a comprehensive review of the program is being undertaken to ensure that it will be simpler for both Parishes and Inspectors and full use is made of the initial report.

The new Model Property Maintenance Program and the associated Maintenance Checklist has been completed. The clergy, wardens and property managers of all Parishes are encouraged to peruse the two documents carefully. They have evolved as a result of the experience gained during the first decennium of the Diocesan Property Inspection Program, and have been essentially distilled from the best practices employed by Parishes. Used with care and discretion they should provide a good and efficient basis for the sound management and maintenance of Parish property. They will also make subsequent Inspections of the Property more effective, simpler and less costly! These two documents together with the Terms of Reference (September 2009) have been posted on the Diocesan website with a new link "Decennial Inspection Committee".

My thanks and appreciation go to the committee for 2008-20098, Mr. David Ricketts and Mr. Bill Holman. Mr. Ralph Crysler has regretfully had to resign for health reasons after some nineteen years of faithful service on the Advisory Committee on Church Buildings and the Decennial Inspection Committee. Ms. Karen Nowicki in the Cathedral office continues her tireless and timely work facilitates the smooth and effective operation of the Committee.

REPORT OF THE BISHOP'S TASK FORCE FOR A SAFE CHURCH

PRIMARY FOCUS:

As a Christian community of faith, the Anglican Diocese of Niagara is committed to creating and maintaining a community in which members, staff, volunteers and guests can work and worship together in an atmosphere free from all forms of discrimination, harassment, exploitation or intimidation.

This group continues to develop our knowledge in offering "best practice resources" within the Diocese of Niagara. Those who serve on this team work at providing basic education to lay people and clergy in the prevention of misconduct. Some of our team members are especially trained in the investigation of circumstances where misconduct is alleged to have taken place

ACTIVITIES:

Those who serve on this team work at providing basic education to lay people and clergy in the prevention of misconduct, and help individuals are communities to reflect on what it is to be a "Safe Church". Safe Church issues range from issues of individual misconduct, the maintenance of healthy interpersonal boundaries to the planning of physical plants to maintain transparency and a safe environment in which community can function.

Our primary activity continues to be the provision of basic orientation the policy *Sexual Misconduct Policy: Sexual Harassment, Exploitation and Assault 2000* which currently governs clergy and lay workers licensed for professional ministry within the Diocese. Our training extends far beyond acquainting people with the policy *per se* and extends beyond "the letter of the law" to help individuals identify circumstances, behaviors and practices which create the potential for unwholesome interactions to occur.

We exist as well, to respond to, (and at the Bishop's invitation, investigate) situations where there is a concern that misconduct may have taken place and where individuals have felt that because of something specific, that the church is not a "safe place" for them. Team members are especially trained in responding to situations where misconduct is alleged to have taken place.

Members of the committee are also available for parishes, deanery groups and Clericus group both to educate people around the nature of harassment, abuse and the misuse of power. In such settings, we assist people in understanding the policy as it currently exists. The creation of a "safer church" is of concern in denominations throughout the world. Many resources from throughout the Anglican Communion and from other denominations are being employed as at the current time, we are in the midst of rewriting our Safe Church Policy. The new policy will reflect not on issues of professional misconduct alone, but also on issues such as bullying and the misuse of power which occurs from time to time within the Christian community.

It should be noticed that increasingly there is a connection between the work of this task force and the efforts of the Volunteer Screening and Development Group, under the experienced guidance of Joyce Wilton, as we work together to insure a safer, healthier church environment.

REPORT OF THE STEWARDSHIP AND FINANCIAL DEVELOPMENT COMMITTEE

The goal of the Stewardship and Financial Development Committee in Niagara is to develop a *Generous Culture of Stewardship* in Niagara through Year Round Stewardship Education, Gift Planning Education, Capital Campaigns, Research and Development, and Communications.

Since the beginning of 2009 the Diocese no longer maintains a part-time stewardship position, but instead hires the services of a part-time Stewardship Consultant, a role that is currently filled by Jim Newman, CMA, O.N.

The Stewardship Consultant's primary duties with parishes involve developing year round stewardship programs, narrative budgets, gift planning initiatives, capital campaigns, parish brochures, and marketing materials, as well as workshops and Sunday morning preaching about stewardship. In addition, he assists the Diocese with other stewardship and financial matters including web site development, targeted campaigns, grant applications, and related committee work.

Currently the Chair of the Stewardship and Financial Development Committee, the Diocesan Treasurer, and the Stewardship Consultant are working closely with the Department of Philanthropy of the Anglican Church of Canada and the Evangelical Lutheran Church in Canada to re-develop a comprehensive Gift Planning program in Niagara.

REPORT OF THE MISSION STRATEGY AND PLANNING COMMITTEE

In today's environment, the work of the Mission Strategy Committee has become of vital importance to the life of the diocese of Niagara. The mission of this group in this past year has been one of creating strategic plans for regional ministry development, providing support to parishes in mission initiatives, making recommendations to synod council and the Bishop and supporting the development and deployment of the Diocesan Vision of 'Pursuing Excellence in Ministry'.

Regional Planning - Mission Strategy has spent considerable time examining the need to explore different ministry models given the challenges we all face with declining resources, aging buildings and higher costs for maintenance. In the Welland area, there has been a discussion ongoing regarding how the five parishes might create a regional ministry plan where they might share clergy support and pastoral care, administrative help and where there is a shared understanding of a common ministry plan for the area. We have discussed at length how, moving forward, as Anglican communities it will be more and more important to broaden the way we think about ministry and be less parochial and protective of our individual congregations. In Halton Hills, the Georgetown/Milton parishes have also engaged in a collective conversation about their future together lovingly referring to their mission plan as STEAM (Serving Together Expanding and Enhancing Anglican Ministry). Bishop Michael Bird appointed the Reverend Canon Dr. Margaret Murray as the missioner for Halton Hills charged with the responsibility of creating a new way forward for these parishes together.

Members of Mission Strategy have also been invited into parishes as consultants to help them create their own strategic plans. St. Aidan's Oakville, under the very capable leadership of the Reverend Cheryl Fricker has been engaged for a number of years now of re-visioning what and who they are called to be in that part of the Oakville community. Their Lindisfarne project has engaged the entire community in determining how St. Aidan's could best reach out to meet the needs of the local neighbourhood. They have developed local partnerships, begun addressing building limitations and how they can re-tool to meet the needs and changed the way they think about being the Church in that place.

Mission Initiatives - This past year saw introduced into the diocese an initiative that comes out of the Church of England referred to as Fresh Expressions. A member of the committee, Andy Kalbfleisch and his wife Sue, have been to England on a couple of occasions studying and learning about this new expression of Christian Church. This experience has translated into Niagara and a number of parishes are exploring ways to offer Fresh Expression of Church for instance the Damascus Fair Trade Cafe in Dunnville or the Hub Pub in Port Colborne. The Kalbfleisch's organized a very well attended Fresh Expressions day in our diocese this past May and if you would like further information go to: www.niagara.anglican.ca/Fresh_Expressions/index.cfm.

Diocesan Vision - Mission Strategy has been very involved in the development and communication of the evolving diocesan vision, Pursuing Excellence in Ministry. The Bishop has spent this fall travelling around the diocese articulating what this vision might look like and mean for parishes across the diocese. This vision will only be realized and effective as parishes understand, embrace and engage in this way forward. We believe that as a Church we are being called to something new so if you want to learn more and engage in knowing how this can be implemented in your parish, please contact the synod office.

REPORT OF THE MISSION STRATEGY AND PLANNING COMMITTEE (continued)

Mission Covenant - Mission Strategy has been looking at the whole experience of transitions in the life of a parish when a new rector is being sought. What is the purpose of the interim period? What is expected of the interim priest through this process? Do parochial committees have the skill set and knowledge to effectively manage this process? Within the diocese there exist a number of programs that all feed into a process of transition, and we have worked at determining how each relates to the other. What is the relationship between Niagara Continuing Education, Fresh Start, the Companions Program and how they effectively prepare parishes and clergy alike for transition? Parishes must clearly understand and articulate their mission and purpose and have that reflected in their parish profiles. Often this is not the case. Mission Strategy wants to have consultants offer expertise and resources to parishes in providing an accurate and realistic picture of their present reality and what the future might hold.

In the same capacity, the Bishop seeks to create a process whereby the parish, new clergy and Bishop himself clearly articulate and understand what is expected of each of the parties in making the parishes' hopes and vision a reality. It is hoped that moving forward, a covenant can be crafted between these parties that makes clear what role each of the parish, Bishop and clergy play in realizing their shared plan for the future.

Re-development Projects - Presently there are two major re-development projects being pursued in our diocese. In Hamilton, All Saints' Church has partnered with an organization called Options for Homes to create an eight story geared to income affordable housing condominium. The present church is beyond repair and will be brought down to make way for this new project. However, the All Saints' parish will move to the first floor of this building with worship space, a storefront ministry and the opportunity to continue their ministry without the paralyzing costs of maintaining a very old building. We want to thank the people of All Saints' for their foresight, courage and commitment in moving forward with this very exciting plan that will guarantee ministry in that area for a long time to come.

The second is at St. Luke's Church in Oakville. This parish is partnering with a retirement residence company to build a retirement home on diocesan property that will also tie in with the ministry plan of the parish. At the same time, this joint venture will provide the opportunity for the parish to re-build their parish centre that will become a hub of activity for the north Oakville area. This is a discussion that has been ongoing for many years so to have this dream almost realized is very exciting in the life of St. Luke's and the diocese. To you members of St. Luke's parish, we also thank you for your courage, perseverance and vision. We pray for all of you.

REPORT OF THE FINANCIAL ADVISORY COMMITTEE (FAC)

The task of the Financial Advisory Committee (FAC) is to advise and report to Synod Council and the Bishop on the management and administration of funds and assets held by or under control of the Synod. In addition, the FAC provides advice and recommendations to the Synod Council and the Bishop on all financial matters that are to come before council for resolution. The FAC works through both its committee and various sub-committees, a number of which have separate reports included in the Convening Circular, in advising and working with the Diocesan Treasurer and CFO, his staff and reporting to Synod Council and working with the Bishop.

This past year has been very much dominated by cash flow issues and by the reality of the Bishop's vision and what that means from a financial perspective. In the short term what has happened is that some monies have been earmarked for this vision in terms of allocating \$150,000 to the parishes for either grants or to move to a one year assessment and we have allocated another \$150,000 for another set of grants that are clergy transition related. Long term, the vision and its financial implications continues to evolve. The result of this is that a new position is being created called Ministry Support Consultant which will be staffed in the latter part of 2010. As you can see in the budget, this will be done through internal staff adjustments. This means that while there are some changes in 2010 more changes should be seen in 2011 and beyond.

As we go forward there are two pressing issues. As referred to above, we do have some significant cash flow concerns. This is a result of the cost to date of the breakaway parishes, cumulative operating losses of around \$1,000,000 for the years 2007 and 2008 and the high number of outstanding receivables that the parishes owe the diocese. The other concern, as we move forward, is that as more and more parishes struggle the possibility of declining revenue is a very real possibility in the very near future. This too will impact how ministry is done at the diocesan level and is something that needs to be prepared for. Synod Council has been made aware of these realities and is in the process of beginning to deal with them.

A piece of good news is that, if projections are correct, it looks like we will have a balanced year-end for 2009. As we move forward I know that I can say, on behalf of the FAC, that they will continue to monitor and advise with much thought and prayer as the Diocese prepares for the future.

REPORT OF THE FINANCE/BUDGET SUBCOMMITTEE

(This Subcommittee is responsible to the Financial Advisory Committee)

The Finance/Budget Subcommittee assists the Treasurer with the preparation of the diocesan budget and monitors diocesan financial operations, including parish loans, loan guarantees and dept repayment plans.

At regular meetings, the subcommittee reviewed the statements provided by the Treasurer and ensured that reasonable explanations were provided for both positive and negative variances to the budgeted amounts. Church extension loans, loans payable, and parish receivable for payroll and DMM are also reviewed at each meeting.

This has been a busy and challenging year for this committee. As the result of the decision by the November 2008 Synod to table the proposed 2009 operating budget until a Special Synod in March 2009, the winter months were spent developing what became

a transitional budget. As we continued to embrace the diocesan vision for the future it became obvious that changes to help make this vision a reality would take time to implement. The budget approved in March began this process by providing \$150,000 to provide both short term grants to parishes which are experiencing financial difficulties and are committed to realizing the diocesan vision, as well as allowing parishes who choose to move to a one year calculation of DM&M from the current three year rolling average.

The proposed budget for 2010 continues transitioning towards the realization of the diocesan vision by re-directing resources in certain areas. An additional \$150,000 has been provided to parishes to provide grants for parishes in transition. We continue to look at staff and diocesan operations to determine the most effective way to deliver services. The economic reality of the present time casts a shadow over how we anticipate implementing plans for the future but as Bishop Bird has indicated many times "the status quo is not an option". While change is never easy, it is important that we continue to examine new and innovative ways around how we conduct our affairs as a church. By engaging our parishes directly in this discussion we will emerge as a strong witness to Christ in our community.

At the time of writing the final details of the 2010 operating budget were still being finalized but it is anticipated that we will have a balanced budget. These are the first steps in a process that will be ongoing.

We thank our current members for their time and care for our ministry of finance in Niagara. We would like to express our profound gratitude to Bob McKinnell, Treasurer and CFO of the Diocese. Bob's diligence and skill are invaluable to our work.

REPORT OF THE INSURANCE AND RISK MANAGEMENT SUBCOMMITTEE

(This subcommittee is responsible to the Financial Advisory Committee)

This subcommittee of the Financial Advisory Committee advises the Diocese of Niagara and its Parishes through the Financial Advisory Committee regarding Insurance and Risk Management.

The program of professional appraisals of the church owned properties is ongoing. During the past year, the insurance building inspection program has been continued by the Diocesan Insurance Broker, David Ricketts. All church properties are inspected and appraised on a rotating three year basis.

A manual on Church Insurance and Risk Management has been prepared by our broker and is available to each parish through the web in the password protected area accessible to Rectors, Wardens and Treasurers. We strongly encourage that this essential document be made available to new Wardens to help with their duties and responsibilities especially regarding their responsibilities for Liability and Money Handling issues.

The subcommittee carried out its annual review of the Synod's policies, with our broker's assistance. All insurance companies are finding it difficult to assess risk. In this Diocese, because of the measures we have taken over the past 15 years. i.e. the program of church appraisals and inspections done by our broker, we find that there is some rate stability. Indeed this year we were able to lower the ratings on all parishes slightly. We are still faced with the continual challenges regarding insurance companies that will entertain our class of risk. It does not help to have a couple of major losses when we go seeking quotes from other companies. Losses over the past ten years have exceeded premiums. Often we think that only property claims are paid but claims under our liability coverage have increased also. Even if a liability claim is not paid there are lawyers' fees, etc.

The new User Group Insurance program is going well for the various groups that rent space in parish properties. This is a mandatory program throughout parishes in the Diocese and further information is available on the Diocesan website.

Insurance is a very complex commodity and again, I want to again thank our broker, David Ricketts. David keeps on top of changes in the market place and advises the committee and the FAC. He is available to assist, at any time, any parish with their questions.

Our Insurance Administrator, Kim Waltmann, is the cheerful voice at the Diocesan Resource Centre to assist you on a daily basis as well. We welcomed five new members to the sub-committee this past year. Their collective insurance experience and knowledge will be a great asset as we deliberate policy options.

REPORT OF THE INVESTMENT SUBCOMMITTEE

(This subcommittee is responsible to the Financial Advisory Committee)

Our Investment Fund was restructured in June 1996 to the current participation unit format. It has been managed by Frank Russell Canada Limited (Russell) since July 1, 2002. Russell uses a multi-asset, multi-style, multi-manager approach to reduce risk and deliver consistent and superior returns. For our portfolio, they currently employ 24 managers.

Russell charges a fee of 52 bps plus GST per year (a basis point (bps) is 0.01%), paid quarterly. Also, the Diocese charges an administrative fee of 50 bps per year, paid monthly. The current total fees are 1.02% per year.

The Synod of the Diocese of Niagara uses a system of participation units through which the Diocese and the participating Parishes share the risks and rewards associated with the investment of their funds. Parishes, who chose to receive a monthly payment, received a 5% cash payout each year up to December 31, 2000 except for 1998 when they received 7.2%. Since January 1, 2001 Parishes have been able to withdraw funds by redeeming units on a monthly basis and this has replaced the cash payout. Unit values were originally set at \$10.00 and they peaked at \$17.30 on June 2007. As of June 2009 the unit value was \$14.03.

The returns on our participation units have fluctuated over a number of years similar with the stock markets. Following are the results, after expenses, as of June each year: June 2003 (1.72%), June 2004 13.56%, June 2005 9.48%, June 2006 7.14%, June 2007 13.33, June 2008 (3.81%) and June 2009 (12.77%).

We thank all of the members who are serving on the committee and in particular those who have recently left for their many years of service to the Diocese through their involvement on the Investment Sub-committee: Mr. Ted Crabtree, Mr. David W. Pady, Mr. Roger A. Philips and Mr. Malcolm Williams.

Re: **2010 Proposed Budget**

Attached is the 2010 Proposed Budget which was approved by the Financial Advisory Committee.

We recognize that a budget is simply a tool wherein we forecast the expected revenues and expenses that will occur in a future period. It gives us a comparison between what we think will happen and what actually happens. The importance of a budget lies in our ability to understand and explain variances that are different than we originally predicted would happen.

This budget is the next step towards realizing the evolving vision of the Diocese of Niagara. In the 2009 budget, we made some reductions in specific expense categories to make funds available to address two specific needs at that time. The first pertained to the Diocesan share of expenses at Cathedral Place and attempts to better match expenses with the role the Cathedral plays in the life of the Diocese. The second was the beginning piece of addressing the DM&M structure that currently exists and moving to a new model. There was \$150,000 available to provide both short term grants to parishes who are experiencing financial difficulties and are committed to realizing our Bishop's vision, as well as allowing parishes who choose to move to a one year calculation of DM&M from the current three year rolling average. This latter opportunity will assist parishes who are experiencing significant reversals in income or operational changes. A number of parishes have chosen to move to the one year DM&M model and we are in the process of setting that up. In addition, parishes have applied for the above noted grant and a decision related to those requests will be made shortly.

For 2010, a further sum of \$150,000 has been set aside in the budget for parish grants under the category Diocesan Operations. This will alleviate some of the pressure on the Personnel Transition and Severance line, as these costs were formerly included under this item.

A new position has been created entitled Ministry Support Consultant beginning in October of 2010. This is an important component of the new vision and is required to implement the covenanting process amongst clergy, parishes and the Diocese.

We have balanced the budget and financed the new items contained therein through a reduction in our commitment to the National Church and not replacing an employee from the finance area who has accepted other employment.

Following are some highlights of the budget which I hope will assist you in reviewing it:

Face Page - Budget:

- There has been no change in the Diocesan Mission & Ministries rate used to calculate the assessment figure. The current rate of 32.83% remains unchanged for 2010. The projected DM&M amount used for 2010 budget purposes is net of the \$150,000 that has been set aside to assist parishes as mentioned above.
- We have not projected any investment return for 2010 as we anticipate these funds will be required to finance our ongoing cashflow needs as well as having offset operating losses for 2007 and 2008, in addition to funding the expenses related to the breakaway parishes. As we identified last year, investments previously decreased as they were the source of the \$850,000 we used to purchase the 1.6 acres adjacent to St. Luke's in Palermo and the \$528,560 representing Endowment Funds which were transferred to the Anglican Church Ministries Foundation, Niagara. The later transfer was done to ensure we maintain the integrity and purpose for which the endowment funds were originally established. Income generated from the endowment funds will support those activities that they were intended for.
- The budget for Synod Council Committees has been reduced to 5,000 and members of Synod Council are now bringing their own meals to meetings of this body.

Page 31:

- A new position is included in the budget entitled Ministry Support Consultant and this will commence in October 2010. This has been mentioned above and will move us forward in realizing the new vision.
- A part-time position has been created named Cemetery Consultant to assist parishes in dealing with the various regulations established by the province with respect to cemeteries.
- The Louisa Parke Fund was totally drawn down during 2005. However, the commitment for a number of retired clergy remains. The \$44,000 amount represents the total monies required, for this purpose, in 2010. It is less than budgeted for in 2009 and it will continue to reduce over the coming years.
- The Treasurer's salary line was reduced in 2010 to reflect the interim position.
- Costs related to the office staff in the Finance area have been reduced in 2010 to reflect the loss of one employee who has accepted alternative employment. It is hoped the work load can be distributed amongst the remaining staff.
- The Investment Fund Administration Transfer represents the fee charged for the administration of Diocesan investments. The service fee transfer projected for 2010 is similar to that budgeted in 2009.

Page 32:

- The Personnel Transition and Severance budget line has increased to \$315,000. It is difficult to anticipate on an annual basis what the appropriate figure should be, since the budget is set well in advance of the next operating year. Since 2000 Survive & Thrive has funded an additional amount of \$70,000 per year for five years and in 2004 a further one time amount of \$200,000 was approved. During 2004 the total amount expended in this category, from all sources, amounted to \$450,000. In 2005 this jumped up to \$590,825. In 2006 this increased to \$703,675. In 2007 it fell back to \$663,884. In 2008 it dropped slightly to \$660,178. For 2009 we are running over budget but at reduced rate compared to 2008. We are hopeful that the 2010 expense amount will be in line with the budget, especially since we have removed \$150,000 from this line by setting up the parish grants.
- The Parish Grants is a new line in name only, as the dollars were previously allocated under the Personnel and Transition line.
- Interest rates have decreased significantly this year so we have allowed for a reduction in Parish Interest/Other Expenses.
- Parish Loan Reduction reflects the annual loan payment we are required to make to our bank each year based on outstanding Synod term loans. This amount was increased in 2005 to \$115,010 as the result of borrowing \$125,000 to meet our commitment on the \$250,000 roof repairs to Cathedral Place in 2005. It is to be repaid over the next ten years.
- > Staff Expenses have been reduced as we attempt to further reduce spending.
- A new category was added in the 2009 budget entitled Recovery Interest on Parish Receivables. A number of years ago, Synod gave approval to Synod Council to implement a program of charging interest to parishes on their Diocesan receivables. Synod Council, on October 14th 2008, tabled a motion to implement a plan to charge interest on Diocesan aged receivables older than 90 days. The approval of the 2009 budget resulted in the implementation of this charge. This action would place the interest cost related to using Diocesan funds squarely with the parish of origin rather than having all the other parishes subsidize the cost. Our current level of outstanding receivables would generate approximately \$43,000 per year and be an offset against interest charged on our bank operating loan.
- The Cathedral Place Building section was changed in 2009 in order that all of the costs associated with the Cathedral Place property were reflected in the budget. The actual 2008 results only reflect the Diocesan share. There has been a reduction in projected costs for 2010.
- In 2008 we assisted the Cathedral by providing some salary assistance which recognized the staff services the Diocese uses when we hold special events at the Cathedral. We discontinued that in 2009 and replaced it with a 50% reduction in the DM&M paid by the Cathedral. This recognizes the time and talent the Diocese receives without attempting to match it to any specific salary.
- As noted above, we have reduced our apportionment to the National Church for 2010.

Page 33:

- Canterbury Hills has proposed a reduction in the Summer camp Program that will see support for this item eliminated over the next three years. Reductions will be in the amount of \$50,000 for 2010 and \$30,000 for 2011 and \$15,000 for 2012. It is anticipated that Canterbury Hills will replace these funds through development of their own fundraising program and the camp will continue in its present form.
- The Chaplaincy Program has been reduced by one third for 2010.
- > Outreach Within The Diocese has been reduced by approximately 66%.

Page 34:

Clergy Development & Education has been reduced in the Divinity Student's and Ordinations categories as the number of students has declined from previous year.

Page 35:

- Another Archdeacon was appointed in 2009 and we have increased the Archdeacons line to accommodate that change.
- The Clergy and Licensed Lay Workers Conference has been reduced to better reflect the dollars being spent in this area.
- Support for the Niagara Anglican has been increased to \$30,000. It has been an ongoing challenge to control costs in this area based on the continuing increase in mailing and production costs. Although we have limited the number of pages that make up the paper, this has only assisted in reducing our production costs.

Our Mission is to develop strong, vital, committed faith communities in the Diocese of Niagara and to nurture the leadership required to create and sustain them.

Through programs, events, training days and parish consultations, Children, Youth and Family Ministries continues to support the Bishop's priorities for the Diocese of leadership, stewardship and evangelism.

Children and Family Ministries

Program Consultant: Christyn Perkons on part-time basis.

- Works to enhance the ability of the Niagara Anglican Community to nurture the spiritual growth of children and their inclusion in faith communities.
- Provides resources and leadership training for Sunday morning programming, junior youth ministry and family ministry to parishes and parish clusters by request.
- Visits parishes by invitation to get to know volunteers and staff involved in children and family ministry; to get a sense of what's happening in parishes across the diocese, and to offer resources.

Family Ministry

- ↑ The annual retreat for families held at the Canterbury Hills Conference Centre each winter has regretfully been suspended for the time being.
- A Resources particular to family needs are available through the lending library and include books in the areas of parenting, family spirituality, family activities, special needs children, sexuality and family milestones as well as games, music and videos/CDs.

Puppet Ministry

• Eighteen puppets along with puppet skits, instruction guides, and training manuals are available for loan to parishes to use in Sunday morning children's programming, children's talks, worship, Bible storytelling, and church announcements. Mini training workshops can be provided to parishes by the consultant, and training days by a professional at a puppet training school are offered as interest dictates.

Children's Festivals

↑ The consultant provides support to the regional Children's Festivals through advertising, administration, and button design/creation. Over 700 children enjoy this event annually which typically occurs on the last Saturday in April. Planning for the 2010 Children's Festivals in Undermount/Mohawk, Lincoln/Brock, Greater Wellington, and Trafalgar began on November 2nd.

Soul Rhythms

- An annual event intended to nourish, nurture and thank parish volunteers Sunday, November 15 at St. Christopher's, Burlington.
- Participants have a choice of workshops (which have included in the past offerings such as Aromatherapy, Sacred Circle Dancing, Drumming, Biblical Gardening, Floral Arranging, Belly Dancing) and also enjoy dinner and a guest speaker.

Lending Library

A wide variety of books, activities, games, music, videos and CDs are available for three week loans through the Program Consultant's office. New resources include:

- This **Outstanding Leadership for Ministry** event provides an opportunity to create relationships amongst the youth and young adult community attending Diocesan Synod, and offers support and education about procedures and meeting content for Synod so that youth are able to take a leadership role.

SpiritQuest

- An intimate spiritual retreat for youth aged 14-24 highlighting **Life Changing Worship** and a **Flourishing Culture of Innovation**.
- SpiritQuest was held at Crieff Hills Retreat Centre in Puslinch, with 10 participants and three leaders, January 30 to February 1, 2009.

1. CONSUMERISM AND HOW IT RELATES TO STEWARDSHIP IN DELEGATES' PARISHES

AND WHEREAS: The actions of Diocesan Youth Ministry show a longstanding track record of commitment to prophetic social justice-making e.g. Youth Synod influencing Diocesan Synod's decision to include issues of social-justice making in its two-day synods, advocating for the full inclusion of gays and lesbians in the entire life of the church and for the ordination of women to the episcopacy, speaking out against sweatshop labour and advocating for fair appeals for refugees, supporting the use of fair trade products, and several poverty reduction motions and actions;

AND WHEREAS: Youth ministry has been a leader in moving toward effective resource management in terms of greening youth ministry events and parishes, of managing volunteers, of bringing food for food banks and generally living out of a theology of gratitude for the abundant blessings which God has given to us;

AND WHEREAS: Youth ministry has helped to give training and opportunities for Christians, young and old, in outstanding leadership for ministry for both volunteer staff and event participants via the Youth Leadership Training program; Youth Synod in general and its Young Adult Mentor program in particular; the Niagara Youth Conference; SpiritQuest; the Diocesan Synod Orientation Program; and many, many more events and programs as well as advocating for leadership training for clergy and laity through Youth Synod;

AND WHEREAS: We are renowned across Canada for both creating and advocating for contemporary, life-changing worship services that fully engage laity and clergy in designing, creating and participating in transformative liturgy that is Spirit-driven, affirming, inclusive, diverse, and highly participatory as well as for training events designed to help participants develop liturgical skills and best practices;

BE IT RESOLVED THAT:

- 1. Youth Synod 2009 affirms the Diocesan vision and resolves to continue its leadership role as the vision is fully realised in the Diocese of Niagara.
- 2. Youth Synod 2009 asks the Bishop to affirm his commitment to living out the diocesan vision in partnership with the youth of the Diocese of Niagara through Diocesan Youth Ministry.

3. INCLUSIVE LANGUAGE IN CHURCH/NON-DEROGATORY LANGUAGE

WHEREAS: It is common for many people to use words such as "gay" and "retarded" in the wrong context (e.g. as synonyms for the word "stupid"). It is profoundly disrespectful to use these words in the wrong context and youth should be encouraged to try and stop using these terms in inappropriate ways;

AND WHEREAS: Our faith has long taught that how we speak matters very deeply, as we can see in many places in the Bible: "For out of the abundance of the heart the mouth speaks" (Matthew 12:34) and "Let your speech always be with grace" (Colossians 4:6);

AND WHEREAS: Scripture is clear that God is beyond gender: "So God created humankind in his image, in the image of God he created them; male and female he created them." (Genesis 1.27);

AND WHEREAS: Youth Synod has had a history of inclusive language in past motions and continues to be committed to ensuring that we speak and act to include all of God's people.

BE IT RESOLVED THAT:

- 1. Delegates no longer use words such as "gay" and "retarded "pejoratively as synonyms for "stupid".
- 2. Delegates encountering others speaking this way will ask those people to stop doing so.
- 3. Delegates try to use both male and female pronouns for God and always keep an open mind about the gender of God.
- 4. Worship at youth events will use gender-neutral language and a balance of pronouns to refer to God.
- 5. Youth Synod 2009 asks the Bishop and the Synod of the Diocese of Niagara to commit to using gender-neutral language and a balance of male and female pronouns in all future diocesan worship services.

AND WHEREAS: In 2005, 2003, 2001 and 1995, Youth Synod advocated for the blessing of same gender unions, and Bishop Michael announced at Diocesan Synod in March 2008 that the Diocese is creating rites for the blessing of civilly married same sex unions, and that he intends to authorize the use of those rites shortly after their completion.

BE IT RESOLVED THAT:

- 1. Delegates will write to their local municipal board members asking them to proclaim May 17, 2010 as international day against homophobia and to fly the rainbow flag on that day.
- **2.** Delegates will petition their high school to fly the rainbow flag from May 15-18th (the 17th is a Sunday this year).
- **3.** Delegates will remove from their daily vocabulary language that would exclude, antagonize or discriminate against people of the Gay, Lesbian, Bisexual and Transgendered ("GLBT") community such as the words gay, dike, fag, pansy, etc. and actively intervene when others use such language.
- **4.** Delegates will sign the Safe Schools Petition, calling for concrete action to provide a safe environment for GLBT students and staff as well as those perceived to be GLBT. (Petition found at: http://www.egale.ca/index.asp?lang=E&menu=1&item=1176)

5. YOUTH OUTREACH MOTION

WHEREAS: Youth ministry events are intended to create safe spaces where we can grow as individuals and leaders, explore and get excited about our faith, and worship in ways different than at church;

AND WHEREAS: Relationships in faith communities are important because they allow youth to connect with others who share similar values and get to know each other on a deeper level than may otherwise be possible;

AND WHEREAS: It is important for those new to youth ministry to feel welcomed and safe at youth events in order for them to participate in these relationships;

AND WHEREAS: In the first Christian community, "the whole group of those who believed were of one heart and soul" (acts 4.32), we see the ideal presented that we are joined through our faith as one and must know and care for one another.

BE IT RESOLVED THAT:

- 1. Youth Synod 2009 asks the Diocesan Program Consultants to coordinate youth ambassadors at all major diocesan events to talk up why it is a great thing to be part of Diocesan Youth Ministry events and what youth will gain from participating in Diocesan Youth Ministry events, and to support that, each Youth Synod 2009 delegate will volunteer to be a youth ambassador for at least two diocesan events in 2009-2010.
- **2.** Youth Synod asks the Diocesan Youth Ministry Committee to create teams to go out to parishes (as invited) to make presentations about the benefits and joys of participating in Diocesan Youth Ministry events, and to support that, each Youth Synod 2009 delegate will volunteer to be part of a team.
- **3.** Each Youth Synod 2009 delegate will, at any Diocesan Youth Ministry event she/he attends from now on, meet and speak to at least one person whom she/he has not met before, and that Diocesan Youth Ministry staff and volunteers will ensure that event participants are reminded to do this at the beginning of each event.
- **4.** Youth Synod 2009 asks Youth Ministry Program Consultants to arrange for non-staff youth greeters at all Diocesan Youth Ministry events, and to support that, each Youth Synod 2009 delegate will volunteer to be such a greeter.

6. BULLYING: A CALL TO ACTION

WHEREAS: bullying is seen as a widespread problem in schools and among youth and is an issue that has touched many at Youth Synod either directly or through friends and peers;

AND WHEREAS: 34% of students in grades 7 to 11 say they are bullied within a school year, and 27% say they have been bullied online;

AND WHEREAS: bullying is very hard for adults to catch and prevent; especially online and non-violent bullying;

AND WHEREAS: 81% of bullying happens in a peer group where friends are pressured into keeping silent about the actions of their peers;

AND WHEREAS: 83% of students who have watched bullying say it made them uncomfortable and 57% of the time when someone intervenes in a bullying situation, it stops within 10 seconds—and peers intervene more often than adults;

AND WHEREAS: the suicide rate among students from ages 10 to 19 is on the rise, and research shows that chronic peer abuse is an additional risk factor for childhood and adolescent suicide for both victims and perpetrators.

BE IT RESOLVED THAT:

- 1. The delegates of Youth Synod 2009 commit to intervening when seeing or hearing about acts of bullying.
- 2. The delegates of Youth Synod 2009 will be mindful of what they put on Facebook, Zipsqueal, MSN and other websites.
- 3. Youth Synod asks the Program Consultants to provide training on how to deal with bullying (both at and away from youth events) to youth ministry volunteer staff.
- 4. Youth Synod 2009 asks the Diocesan Youth Ministry Committee to address the issue of bullying at events such as The Gathering, NYC, YLTP, etc.

7. END THE GENOCIDE IN DARFUR

WHEREAS: Genocide is the deliberate and systematic destruction, in whole or in part, of an ethnic, racial, religious, or national group;

AND WHEREAS: Genocide in Darfur has killed 400,000 people to date, and displaced more than 2.5 million people since 2003;

AND WHEREAS: After the Holocaust, our world leaders pledged that genocide would never happen again, but since that day incidences of genocide have occurred without intervention from the worldwide community in Cambodia, Bosnia, Rwanda, and now Darfur;

AND WHEREAS: God commands us to "Love each other as I have loved you. Greater love has no one than this, that he lay down his life for his friends," (John 15:12-13);

AND WHEREAS: God calls us to be responsible to help every person to bring about God's reign;

BE IT RESOLVED THAT:

- 1. All delegates will become a voice for Darfur by sending a post card to the Prime Minister and their MPs and/or will call 1-800-GENOCIDE to show that we join the Save Darfur! campaign in supporting: the promotion of peace, the protection of civilians, punishment for the perpetrators of genocide, prevention of future genocides
- 2. Delegates will become a member of the Save Darfur Coalition to get updates on how they can help work against the genocide in Darfur (savedarfur.org) and sign the petition to urge China to stop protecting Sudan and aiding the genocide in Darfur (http://action.savedarfur.org/campaign/chinaolymp).

- 3. Delegates will host a film screening at their home parishes and/or schools using the <u>Darfur: A Call to Action</u> video and discussion guide and urge the parish and/or school to take action to help Darfur, including, for parishes, to become a Congregation of Conscience http://www.savedarfur.org/page/s/faith postcards.
- 4. Delegates will write to their local newspaper about the crisis in Darfur, what they are doing to try to stop it, and the importance of covering the Darfur crisis in our media.
- 5. Delegates will pray daily for an end to the crisis in Darfur.

 - Campers attend with the support of the Canterbury Hills Camp Bursary Fund

And as we gather for Synod this fall, it has already started for the 50th time, as 2010 will mark the 50th summer that a children's summer camping program has been offered at Canterbury Hills. That's over 25,000 children whose lives have been significantly impacted in the context of a loving and caring Christian community. That's well over 1000 young adults who have been trained as exceptional leaders and then gone on to use their skills honed at Canterbury Hills Camp in their parishes, their communities, and their vocational pursuits. That's the legacy we'll be celebrating as we move into 2010!

As we reflect on Summer Camp 2009, we give thanks for the leadership of Ms. Heather Pearson, our Camp Coordinator this past summer, the members of the Resource Team, and all the members of the Staff Team who worked incredibly hard to ensure that the children entrusted to our care had a safe and memorable summer camp experience. We give thanks for the Camp Alumni members who staffed BBQs at the Open House and opening night of each of the residential sessions, thereby raising \$2,000.00 for the Camp Bursary Fund. We give thanks for the six diocesan priests who came out to celebrate the closing Eucharist at each of the camp sessions. We give thanks for the financial support of the Diocese that has allowed this wonderful ministry to flourish these past 49 years. And we give thanks for all the lives touched and changed by God in ways that we could never have "asked or imagined".

And we pray that will all happen again in 2010.

REPORT FROM THE DIRECTOR OF TRANSITIONAL MINISTRIES

Interim Ministry

The time of pastoral transition in a congregation is often a complex time. For that reason, in the Diocese of Niagara, we practise Interim Ministry, which is a time of the intentionally focused work of pastoral and administrative care and leadership. In our Diocese, clergy who are interims have been specific trained for this work. The interim placements generally extend from between six to twenty-four months, and are held at the Bishop's pleasure.

This past year, we have significantly re-vamped the Diocesan Policy for Interim Ministries. At the present time, the draft policy is in the hands of our Diocesan Bishop, and in due time will be presented to Synod Council for review. Specifically, new policy seeks to clarify the financial policy, issues around benefits, hours worked and vacations, travel costs, among other things. We are indebted to the Reverend Susan Wells who chaired this Task Force, as well as to the Reverend Canon Fran Darlington, the Reverend Barbara Sykes and the Reverend Canon Terry DeForest for their dedicated work in creating this revision.

New to this policy is a three way covenant, between the Diocesan Bishop, the Parish and the Interim. Not all parishes are the same, of course, nor are the circumstances pertaining to each interim appointment. The covenant agreement allows for specific issues and tasks to be named by the parties which may need attention in the individual interim appointment. (For example, a specific parish may be in transition from an individual parish to being part of a parish cluster. If so, not only their identity will need a different kind of reflection, but also their expectations and ways of functioning will need to change.) By specifically naming these concerns in the covenant, work in addition to the usual developmental work of interim time will be facilitated.

Fresh Start

In the recent past, Fresh Start has been a programme which has assisted both clergy and congregations during the time of pastoral transition. Originating in the United States with the Episcopal Church, Fresh Start has developed considerable Canadian content over the past years. Fresh Start 2.0 reflected that contribution. Within the past year and a half, Fresh Start has evolved yet again, to Fresh Start 3.0. It brings a wider range of resources, and a depth of information to parishes and clergy dealing with transition. Although external structure has stayed the same, many of the modules would be virtually unrecognizable to people who participated in earlier versions of the programme.

In the past year, two groups of parishes have "graduated" from Fresh Start. I thank especially, the Reverend Canon Bill Thomas, the Reverend Jean Archbell, and Mrs. Laurie Adamson who have shared with me, leadership in facilitating these two groups. At the present time, we have one cluster of parishes engaged in Fresh Start. Mrs. Ruth Anne Martin shares leadership with me in that particular group.

Much changes in Diocesan life, and we are currently engaged in a conversation about how best to serve clergy and congregations in transition. The shift to sometimes appointing new ordinands to incumbencies creates a dilemma about how best to address the needs of those clergy and others.

REPORT FROM THE DIRECTOR OF TRANSITIONAL MINISTRIES (continued)

At the request of Bishop Bird, we are currently in the process of evaluating our Diocesan Fresh Start participation, so we can better learn specifics of how it has benefited clergy and congregations, and to hear what other needs may need to be addressed.

This past year, Archdeacon Stephen Hopkins, who has been a key leader in the Fresh Start programme, within the Diocese of Niagara and throughout Canada and the United States has submitted his resignation to our Diocesan programme. We thank Archdeacon Hopkins for his invaluable contributions, and the echo of his wise question: "What can we learn from this?" will long ring in our ears.

The staff team ensures that the guests at Canterbury Hills are welcomed warmly, fed abundantly, and kept safe and comfortable during their stay. The staff also ensures that the facilities are clean, well maintained, attractive and actively protect the natural setting of Canterbury Hills.

Canterbury Hills is a property of the Diocese of Niagara. Like any property with land and buildings to care for there are always constant repair and maintenance issues to deal with. REPORT OF BROCK REGIONAL COUNCIL

Brock Region encompasses the half of the Niagara Peninsula that includes Dunnville, Wainfleet, Port Colborne, Fort Erie, Niagara Falls (and previously Chippawa), Fonthill and Welland. All the parishes are represented at meetings the first Wednesday of the month. Each meeting is held at a different parish in the region, even though distances can be daunting. This exercise has made our region "smaller" in the sense that we know our region better and it has offered us opportunities to visit and learn first hand about other parishes.

The format of most meetings is a presentation by a guest speaker on either a topical subject or an activity of the Church which needs support or wider understanding. An important element of the business meeting is the report from Synod Council which updates parish reps on the various matters of concern from the Diocese and any proposed changes to Canon law or policies and the budget intentions. The business portion of the meeting is also an opportunity for parishes to discuss new ideas and discover new ways in which to grow.

Some of our time and focus has been and will continue to be on the role of the council in the region. We are in the process of trying to find the answers to such questions as:

- How can we be of the greatest assistance to the parishes within the region?
- Who are we?
- Where are we going and what do we need to do to get there?
- What should be our role in addressing specific Diocesan issues such as pandemic planning and the greening of Niagara?
- How will we incorporate the Bishop's vision?
- Etc., etc., etc. there are many more questions that still lie ahead.

In order to grow and thrive, we, like everyone else must take stock of where we are and use the answers to the questions to establish the destination of our continuing journey.

REPORT OF THE UNDERMOUNT REGIONAL COUNCIL

The Ten Tribes of Undermount

Undermount Region lies below the mountain "Niagara Escarpment" from Winona on the east to west of McMaster University and north to Hamilton Harbor and Lake Ontario. It is a region of agriculture, educational facilities, shipping and both light and heavy industries. We have ten parishes including the Cathedral. We also have St. Matthews House and three community outreach centers located in our region. Jamestown near the Cathedral and the McQueston Centre close to the Church of the Nativity as well as the ABC food program operated out of the Church of the Ascension. The Mission to Sea Farers, situated in the Hamilton Harbor Area serves visiting sailors from ships of many countries which dock in Hamilton. The sailors have access to the internet so they can talk to those back home, and opportunity to visit Niagara Falls along with many other activities that the Mission offers to them. We are the smallest Region in the Diocese in mileage but powerful in spirit. Our welcoming parishes are a great diversity of worship services from Anglo-Catholic to Evangelical, from liberal to Conservative. These represent the diversity from street folk, university and college students to the descendants of the founding fathers of Hamilton. Undermount also offers many sizes of spaces and buildings from the grandeur and beauty of the Cathedral to the carillon and "rural" beauty of St. John's in Winona. From majestic pipe organs and hymn books to guitars, drums and Power Point. From the traditional inspirational quiet services to lively, invigorating, inspirational worship, as a region we offer something somewhere for everybody.

We continue as a region to work on the Greening Niagara Committee and are part of the testing process for accreditation as a Green Parish at either Bronze Silver or Gold level. At some point during this session of Synod you will hear of the progress in this area. The parishes in Undermount have greatly reduced waste, recycled ferverently and overall have taken on the challenge of making our region a Greening Region. We encourage you to look at the Greening Niagara portion of the Diocese of Niagara web site to learn about many innovative ideas, programs and posters that you can use in your home parishes. During the past year our Regional Council held discussions on requirements for the Order of Niagara and are working at our Regional meetings on the Diocesan Vision. We were one of the first regions in our Diocese to hold a special meeting, attended by several people from each parish, with Bishop Michael present to inform parish members of this vision. They have taken the information they received back to their home parishes for parish input and action

One of the mandates of a Regional Council is to "support, encourage and facilitate the mission of the church in response to local and regional needs" Canon 1.10. 5(a). Many of our parishes are actively working locally with faith groups of other denominations and are active with Children's Festival, Bible Study, Prayer Groups, Out of the Cold, Open Doors Hamilton, Seniors activities, Youth Clubs, College and University Outreach, Scouting and Guiding, breakfast programs and AA groups. For the past three years on Victoria Day, one parish, St. Alban the Martyr works with six other denominations to have a Party in the Park located opposite it. Christian music, displays, prayer table, games, face painting and food are available to the neighborhood. This year close to 1,000 youth and adults attended the event. St. Alban's has recently started a new program, Parenting Skills for Teen Mothers. Our Regional Council Outreach this year was a monetary and donation of food items in support of St. Matthews House.

REPORT OF THE UNDERMOUNT REGIONAL COUNCIL (continued)

We hold bi-monthly Regional Council meetings. These are attended by both clergy and lay representatives. Each parish attending the meetings informs the others of their successes with events they have held and also future activities. That way we all share in the spread of great ideas that each of us can take back to our own parishes. The Council reps are also made aware of any Diocesan programs that may be new to them or that they need to take action on in their home parishes. All of us feel it is truly thrilling to be a small part of making a difference in the life of our parishes, Undermount Region and our Diocese of Niagara.

REPORT OF THE DIOCESAN ARCHIVIST

It is important for us to be reminded of the vital part McMaster University in Hamilton plays in maintaining our Diocesan Archives. Since 1975 we have had a an agreement with the Mills Memorial Library of McMaster to store in their humidity controlled rooms our important archives, registers, documents etc., there is no charge to any parish for this service. It is covered in our diocesan budget. If copies are need of any baptism or marriage record a nominal fee of \$25 is charge to the person making the request.

We have made a good start on our Stained Glass Window Registry. In a Diocesan letter from Bishop Bird sent to all parishes in April 2009 the importance of this Registry was noted. Already a number of churches have had their stained glass windows photographed and recorded. It is very important that the dedication of said windows be clearly recorded. With the closure of some churches and the possible sale of the building, with or without windows, the Diocese needs to aware of the location of all our windows. Families who gave the windows many years ago want to know where "grandfather's window" can be found.

One church, St. John's Elora, has embarked on a long range program to inspect and restore their windows. I'm sure they would share their experience with any other parish.

We have recently acquired some "holy hardware" from some closed churches and have been successful in finding permanent homes for these valuable items. A record has been kept of the new homes so that the items can be traced if needed.

Your Archives has printed a very complete and valuable resource booklet entitled "Archives – Our Story" and details what things are of an archival nature and should be kept and for how long. We also have a comprehensive booklet on 'Stained Glass Care" for parishes. The booklets were distributed to each parish, but if extra copies are required call Cathedral Place 905.527.1316 x450.

Copies should be made of any plans or blueprints and filed in the Archives at Cathedral Place. I have a file of resources on each parish and this information may be of assistance for anyone writing a history of their parish.

It is important that all names on registers for baptisms and marriages be <u>clear and legible</u>. These should be printed along with the signatures for future archival purposes.

REPORT OF THE CATHEDRAL PLACE PROPERTY MANAGEMENT COMMITTEE

The 2009 members of the Cathedral Place Property Management Committee are Diane Dent, Paula Esteves, Barbara Jepson, and Janina Vanderpost (Chair) representing Cathedral Vestry, and Mitch Banks, David Pickett, Ian Pratt and Robert Tilbury appointed by Synod Council. The *ex officio* members are the Executive Archdeacon, the Diocesan Treasurer and the Dean. The committee has met three times so far this year and will meet once again before the end of 2009.

As reported last year, a unified budget for Cathedral Place has been instituted. The Committee oversees this annual budget and, in this regard, receives regular updates from the Diocesan Treasurer on the status of the budget. As at September 17, the Committee is advised that the 2009 budget is on track. At the September meeting, Committee began reviewing expenses for the upcoming year for the purpose of developing a draft 2010 budget. A Cathedral Place budget and recommendations will be presented later this year to Synod.

A significant development this year was the appointment on January 5, 2009 of Roger Cassey as the new Cathedral Place Property Manager. Mr. Cassey came to us with a wealth of property management experience and he has made substantial advancements in the overall management of the property especially in areas such as staffing and working with contractors. Many of the efficiencies he has introduced will result in cost savings. There have been major undertakings to do with fire and safety, painting and other maintenance, air conditioning, security and event booking procedures. For the immediate future, efficiencies in snow removal are being examined. A longer term schedule for the repair and maintenance of stained glass windows is in place and insurance claims are being made for recent damage, from vandalism, to some windows.

On May 11 the Committee met with Kiki Aravopoulos of Ontario Heritage Trust and Meghan House, a heritage planner from the City of Hamilton. From these representatives we learned about the mandates of their organizations and some of the procedures and processes that must be followed when maintaining or upgrading designated heritage buildings such as the Cathedral.

A general agreement between Cathedral Place and the Jamesville Children's Centre is in place and working well.

Plans for celebrating the cathedral's 175th anniversary in 2010 are well underway. No major property enhancements are proposed for this event.

The legal agreement establishing Cathedral Place, first drafted in November 1995 and amended by the Committee in October 2007 is not yet signed but follow-up is continuing.

REPORT OF THE CEMETERY CONSULTANT

The Cemetery Consultant position functions as a resource offering support, advice and guidance for parish corporations and trustees entrusted with the operation and care of cemeteries, niche walls, scattering gardens and columbariums. It assists with the interpretation of and adherence to provincial guidelines and legislation governing cemetery operations and additionally, provides advice and support relating to situations and concerns that may occur.

During the preceding twelve months the Consultant has provided corporations and trustees assistance and support relating to the following circumstances:

- The regulations governing the sale of abandoned church cemetery lands;
- The procedure required to disestablish a cemetery (columbarium) upon the sale of church property and further, the requirements governing the relocation of the columbarium to another church cemetery;
- Reviewing and updating cemetery bylaws and contracts of sale;
- The expansion of an existing cemetery;
- The regulations associated with liability issues relating to the maintenance and care of memorial markers;
- Licensing and reporting issues;
- The relocation and interment of human remains from an abandoned cemetery;
- Advice concerning inaccessibility of a cemetery plots due to substantial tree growth.

As part of the Diocesan Resource Centre, the Cemetery Consultant extends an invitation to all parish corporations and cemetery trustees seeking assistance or advice concerning operations, regulations, and other cemetery matters. NIAGARA CONTINUING EDUCATION

Newly ordained clergy in our diocese are expected to participate in the first two years of their ministry (with a 3rd year optional) with a programme known as Niagara Continuing Education. We meet three times per year in an overnight session held at Canterbury Hills. Participant driven in terms of our themes, our sessions have alternated between professional skills development and the health and wellness of clergy as leaders.

In February of 2008, Bishop Michael Bird who presented an early version of his vision "Pursuing Excellence in Ministry". It was also a time for both Marion and I to get on board with our participants and solicit their input into our upcoming programme.

In May of 2008 our overnight session focused on "Sustaining Spirituality for Ministry" with Canon Audrey Conard as a resource person. As a spiritual director to many clergy, Audrey had some important insights for our participants.

In October of 2008 we had a visit from the Venerable Rick Jones who ran a session on the "Do's and Don'ts of Running a Vestry Meeting." As an experience clergy, Rick was an excellent resource to newly ordained clergy preparing for their first Vestry meetings as Rectors. We also had an excellent session with the Reverend Sue Steiner from Conrad Grebel College. Sue's focus was on "Managing Conflict in Faith Communities." She is a consultant in this area and brought good practical knowledge and a grounded theological overview of the issues involved as well.

In February of 2009, Dr Wanda Malcolm from Wycliffe College led a very informative session on "Clergy Wellness." As a therapist in private practice, Wanda brought both her professional background and her own deep faith experience to our discussion of this important area. Wanda was also involved in a large research project in the diocese of Toronto on clergy mental health and had plenty of insights to share from her involvement in this study.

In May of 2009 our theme was "Navigating Change in Congregations - A Lay Perspective." We were fortunate to have the assistance of Rob Reid and Bob Morrow with background help from Fred Hall. Each of these men has extensive experience as volunteer consultants in the diocese and had many important things to share from their perspective as lay persons involved in parish life.

In October of 2009 we had a visit from the Reverend Dr Paul Wilson, professor of homiletics at Emmanuel College. In response to participant input, Paul explored the theme "Sustaining Energy in Our Preaching - *Especially When We've Been Through The Lectionary Several Times*."

Each session also includes a fairly lengthy check-in. This is an opportunity for clergy to reflect upon both their personal and professional lives in a supportive and safe atmosphere. Worship and community building are also important components to NCE.

We appreciate the support which the diocese offers in this area of our common ministry. While both the Venerable Marion Vincett (retired) and I are volunteers, the accommodation, meals and resource costs are sponsored through the diocesan budget. It's a worthwhile investment in the ongoing formation and support of our parish clergy in the first two years of their ordained ministry.

Marion and I have shared in the co-facilitation since the February of 2008 and have enjoyed the ministry we've shared with our newly ordained colleagues.

REPORT OF THE GREENING NIAGARA COMMITTEE

In our diocese, our churches and our people have long expressed a concern for creation that is consistent with the fifth mark of mission of the Anglican Communion: "to strive to safeguard the integrity of creation and sustain and renew the earth".

More recently, this concern has been articulated in the diocesan vision. The Greening Niagara committee seeks, through its ministry, to enable all of us to live out this mark of mission as part of our commitment to God's mission in our world. Below we've highlighted some of our work over the past year.

Approval of Mandate

On October 14, 2008, Synod Council approved the mandate for the work of the Greening Niagara committee. The mandate outlines the immediate priorities of the committee and the scope of its work in our diocese. Our work focuses on four key areas: developing and implementing sustainable best practices, greening our buildings in partnership with the Bishop's Advisory Committee on Church Buildings (BACCB), animating parishes by equipping and inspiring local green teams, and educational initiatives to reflect theologically about issues pertaining to creation.

Greening Facilitators

We developed a ministry position description for a parish Green Facilitator: someone who is the point person at the parish for matters pertaining to greening; gathering a group of volunteers together to form a green team and liaising with the parish leadership and Greening Niagara committee to reduce the parish's footprint on the earth and undertake practices which are more sustainable. Parishes were invited to designate a Green Facilitator as part of their vestry reporting forms and forty parishes have done so to date.

Gathering & Producing Resources for the Webpage

If you haven't already found it, you'll want to check out our webpage on the diocesan website at: www.niagara.anglican.ca/green. The Greening Niagara committee has worked hard over the past few months to produce and gather several new resources for use in your ministry. Among the new resources, you'll find detailed information about the options available for church energy audits, suggested best practices for various aspects of ministry, and a report by the St. James' Greening Group on green cleaning. Check back often as resources are continually added as they are developed and compiled.

Developing & Piloting the Green Parish Accreditation Program

In response to a motion from this synod in 2007, a good deal of our energy over the past year went into the development of a Green Parish Accreditation program. Sue Carson and Susan Curran deserve our gratitude for spearheading this work. The goal of the program is to encourage parishes in their work towards undertaking their ministries in a more sustainable manner. Similar programs have been developed in the dioceses of Ottawa and New Westminster. As part of the program we also developed a tool, the Niagara Home Challenge, for individuals to use in their own homes. This past summer nine parishes participated in a pilot of the Green Parish Accreditation program. We're grateful to these parishes for their willingness to participate, and for their feedback regarding how we can improve the program. We're looking forward to unveiling the full program at Synod in November.

REPORT OF THE GREENING NIAGARA COMMITTEE (continued)

Encouraging Participation for Earth Hour, Earth Sunday and the International Day of Climate Action

Throughout the last year, our committee has encouraged parishes to participate in opportunities to reflect upon our faith's concern for creation. Bishop Michael's pastoral letter supported KAIROS' call to Canadian Christians to participate in Earth Hour on March 28 as a symbol of our concern for the care of creation. Several parishes held vigils during the hour; and overall energy demand in Ontario was reduced by more than six percent during Earth hour. Many other parishes held an Earth Sunday service on the Sunday before Earth Day (April 19). At the time of writing this report, several parishes are also planning initiatives as part of the International Day of Climate Action (350.org) which is scheduled for Saturday, October 24th. This is an international campaign to bring awareness to climate change by reminding our politicians and decisions makers to pursue strict goals around carbon emissions in advance of the upcoming meeting in Copenhagen, Denmark. The focus is on the number 350, which represents 350 parts per million of carbon dioxide in our atmosphere, which scientists have identified as the safe upper limit of carbon dioxide in our atmosphere. We're currently at 385.92ppm.

Supporting Parishes & Ministries in their Greening Work

Members of the committee have been available to give support, advice, and wisdom to various groups and individuals throughout our diocese about sustainable practices for our ministry. We've made presentations to Synod Council, the Secretaries of Niagara Anglican Parishes, and the Canterbury Hills Board. We're also committed to working as partners with the BACCB and with Niagara's Justice Camp. Our goal is to be partners with the parishes and people of our diocese. At the same time, we hope that in the course of your work you'll also share wisdom with our committee too. We invite you to contact Russ Kelk (firstrover@aol.com) or Bill Mous (billstjames@bellnet.ca) with information and resources that we might share with the diocese or if we can be of assistance to you in the work of your parish or ministry.

Over the past year a great deal of work has been done in order to lay a solid foundation for our diocese's vision of more fully living into what our faith teaches in regards to environmental sustainability issues. In the coming months we look forward to working with even more parishes and groups in our diocese to 'green' our ministries. The Green Parish accreditation program is an excellent start, and we hope to report that next year many parishes have become accredited green parishes.
